


IBAN

With the accession of the Czech Republic to the European Union (EU) on 1 May 2004, there is an obligation to indicate beneficiary account in IBAN format and beneficiary bank in BIC format when making payments to the countries of the European Economic Area (EEA) *, which make foreign payments faster and safer.

International Bank Account Number (IBAN)

International Bank Account Number (IBAN) is an international standard for bank account numbers. It uniquely identifies the client, his bank, and the country. It is used in foreign payment systems (the term cross-border payment is newly used). Each EU country has its own IBAN structure that contains a maximum of 34 characters (digits and capital letters) each of which has its meaning and cannot be omitted (eg zeroes). This account number is easily computerized and can help to identify its incorrect form (check number in the account number) in a timely manner, which could lead to a payment delay or claim. Thanks to its structure, IBAN enables fully automated payment processing, which in turn will also lead to a reduction in cross-border payments. The clients of the EU banks were acquainted with IBAN by their banks.
