- Achieving asset appreciation without using equity positions.
- The investments comprise credit, market, currency, liquidity and emerging market risks.

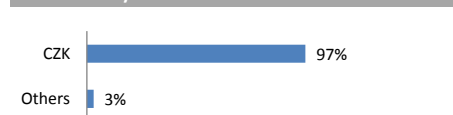

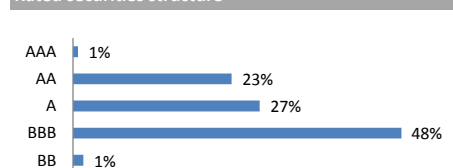
## Recommended investment horizon
